#### MATTER: REQUEST FOR INFORMATION OF PUBLIC IMPORTANCE

Dear Mrs. Malović,

According to the Law on Availability of Information of Public Importance, on 23 June 2011, I contacted you with a Request for establishing the facts of publicly disclosed statements in news media related to the existence of „political racketeering“ and abuse of office of public prosecutors. (Request attached hereto).

You are kindly asked to provide me with documented information on the results of the measures and steps that have been taken by you *ex officio* in regard to our request.

#### Explanation

Public statements given by the members of the Executive branch of Government who are now private businessmen, that the top politicians are racketeering the corporations and that the political racketeering and extortion wherein the top politicians as well as local level politicians are implicated is the cause of a general criminalization of Serbian society as a whole, gives way to suspicion of all Serbian citizens in the existence of the Rule of law in this country. Public statements and declarations that according to political instructions of private individuals the public prosecutor's office and judiciary actively work with the police on covering up the investigations and prosecute the whistle blowers“, additionally ruin the credibility of the Rule of law and authenticity of fulfilled standards of International community
