



**SAOPŠTENJE UDRUŽENJA „PRAVO NA ZDRAVLJE“ O DOKUMENTU AGENCIJE ZA BORBU PROTIV KORUPCIJE SRBIJE : „IZVEŠTAJ O OBLICIMA, UZROCIMA I RIZICIMA KORUPCIJE U SISTEMU ZDRAVSTVA“**

U proteklih deset godina **najveći civilizacijski neprimereni korupcionaški skandali** desili su se u zdravstvu Srbije. Za neke od tih afera, Stiven Kon, dir. Vašingtonskog centra za uzbunjivače podvukao je potrebu razmatranja ne termina korupcija već **masovnog ubistva** . **Izveštaj Agencije za borbu protiv korupcije karakteriše pogrešna metodologija, netransparentan rad i očigledna nekompetentnost učesnika u izradi Izveštaja što je dovelo do:**

- **pogrešno utvrđenih uzroka i oblika korupcije u zdravstvu Srbije**
- **pogrešnih preporuka za suzbijanje korupcije u zdravstvu Srbije gde je izbegnuto čak i pominjanje slabosti državnih i nezavisnih institucija kao bitnog uzroka i nosioca korupcije u zdravstvu Srbije.**

Izveštaj tendenciozno pogrešno ukazuje da su glavni krivci i nosioci korupcije u zdravstvu **direktori zdravstvenih ustanova i navodno neuređen odnos lekar-pacijent.** Ovo pogrešno ukazivanje izaziva našu zabrinutost jer negira realnost institucionalne korupcije **a time i potrebu borbe protiv nje.**

**U zemljama evropske unije, lekari i pacijenti varaju osiguravajuća društva i državu, zato se to i zove prevara. U Srbiji država i državno osiguranje varaju lekare i pacijente i to se zove sistemska korupcija pa i organizovani kriminal. Ovo je razlog zato se u Srbiji ne mogu primeniti iskustva i postupci za suzbijanje korupcije koje primenjuju zemlje evropske unije.**

Sve ovo nas drži u uverenju da je i sama svrha pravljenja ovako koncipiranog izveštaja bila **simulacija borbe protiv korupcije i davanje alibija odgovornim funkcionerima zbog sve veće zainteresovanosti Evropskog parlamenta i bojazni od trajno otvorenih Poglavlja 23 i 24**

**ANNOUNCEMENT OF THE „RIGHT TO LIFE“ NGO REGARDING THE DOCUMENT OF THE SERBIAN ANTI-CORRUPTION AGENCY INTITULED: „REPORT ON FORMS, CAUSES AND RISKS OF CORRUPTION IN HEALTHCARE SYSTEM“**

In the past ten years the biggest corruption scandals unbecoming a civilized country have happened in the Serbian public healthcare system. For some of these corruption scandals, Dr. Steven Kohn, director of the Washington Whistleblowers Center has underlined a need to use the term **mass murder** instead of corruption.

**A Report of the Anti-Corruption Agency of Serbia is characterized with wrong methodology, non-transparent work and evident lack of competence of the participants in drafting the Report which has caused the following:**

- **Erroneously determined causes and forms of corruption in Serbia's public healthcare system**
- **Wrong recommendations on how to eradicate the corruption in Serbia's public healthcare system, where there is no mention of the weaknesses of the Government and independent institutions as a key factor and promoter of corruption in Serbia's public healthcare system.**

The Report intentionally and erroneously points that the main culprits and promoters of corruption are the directors of the medical /healthcare institutions and allegedly the unregulated relationship between a physician and medical patient. This erroneous allegation causes our anxiety because it negates the reality of institutional corruption and thereby a need for fight against such corruption. In European Union countries, physicians and patients are defrauding insurance companies and the Government as well, and that is simply called the fraud. In Serbia, the Government and Government-run insurance companies/funds cheat the physicians and patients and that is called the systemic corruption and also the organized

Mišljenja samo da ovakav pristup predstavlja i zloupotrebu poverenja i sredstava Fondacije Konrad Adenauer.

Stoga, iz do sada nevedenih činjenica misljenja smo da ovaj dokument ima vrednost samo kao potvrda da su **Institucije Republike Srbije napokon priznale potrebu za rešavanjem metastazirajuće korupcije u zdravstvenom sistemu**. U postupku utvrđivanja oblika, uzroka ili rizika korupcije i preporuka za njihovo uklanjanje, **ovaj dokument nema nikakvu praktičnu vrednost.**

organized crime. **This is the reason why in Serbia proper the experience and procedures in fighting the corruption applied in the EU countries cannot be implemented.**

All of this makes us think that the very purpose of drafting such a report is **the simulation of fight against the corruption and giving an alibi to officials in charge due to an increasing interest of European Parliament and fear of permanently opened Chapters 23 and 24** <http://www.euractiv.rs/eu-i-zapadni-balkan/3277-dva-koraka-nazad-u-proirenju-eu.html> of the Questionnaire on Joining the European Union.

We are also of the opinion that such approach constitutes an abuse of trust and funds from the Konrad Adenauer Foundation.

In the premises, and based on the said facts, it is our opinion that this document's only value is that it is a confirmation that the **Serbia's institutions have finally acknowledged the metastasizing corruption in the public healthcare system.** In the procedure of determining the forms, causes and risk of corruption and recommendations for their elimination, this document has absolutely no value at all.
