U prilogu ovog pisma dostavljamo vam kopiju dopisa koji smo uputili Ministru Pravde, Visokom savetu Sudstva i Visokom savetu Tužilaštva a gde smo između ostalih naveli i ovaj korupcionaški skandal.

Dear Mr. Mayor,

In the past 4 years we have informed you with supporting documentation regarding the corruption under the patronage of the City of Belgrade services – confiscation of the public property.

Regarding the confiscation of public property, contrary to the interest of citizens of Belgrade, we have sent you two undisputed documents, signed by 15 858 citizens of Belgrade. You have been notified of this usurpation of property by the president of Voždovac City Hall and the Attorney General of Serbia who ordered you in writing to take adequate action as prescribed by the law. **You are hereby informed of the fact you already know very well-so far nothing has been done in this matter.**

Enclosed hereto we are sending you a copy of the letter which we sent to Justice Minister, High Council of Judiciary and High Council of Public Prosecutors, where we also mentioned this corruption affair.
